The Gold Coast Waterways Authority (GCWA) is investing \$35.3 million in projects over four years to sustain, enhance and promote our waterways.

About the Project

This project will maintain clear access to the Tipplers Passage navigation channel and anchorage and a small section of the North Channel where it intersects the North arm of the Coomera River. Sand from the dredging will be reused to upgrade the South Stradbroke Island Tipplers Precinct foreshore, to replenish eroded areas and to protect property.

There is a chance that some of the sand that will be pumped onto the beach will contain fine particles from the seabed floor that will give it a dark appearance for a short time. These fine particles should settle out of the material within the first two months after placement and the foreshore will return in appearance to its natural state.

Large machinery and other equipment will be required on the foreshore to create sand settlement ponds and to shape the sand to the desired profiles.
