

WATERWAYS NOTICE

Notice to control activities or conduct in Gold Coast waters
Gold Coast Waterway Authority Act 2012, sections 22, 23 and 24



I, **Chris Derksema, Chief Executive Officer, Gold Coast Waterways Authority (the Authority)**,
by this waterways notice (the Notice):

- 1. Establish the Marine Stadium Works Buffer Area (Works Buffer Area) in waters of Marine Stadium.**
- 2. Require a person in charge of a watercraft to move the watercraft out of the Works Buffer Area before 8:00 am on Friday, 9 December 2022.**
- 3. Require a person in charge of a watercraft not to enter into, navigate, anchor, moor or otherwise operate the watercraft on, waters of the Works Buffer Area before 8:00 am on Tuesday, 28 February 2023.**

The requirements of the Notice apply to watercraft on waters of Marine Stadium.

The requirements of the Notice do not apply to:

- a) watercraft owned by the State
- b) watercraft being used to carry out construction of the Marine Stadium jetty and pontoon (the Approved Work) within the Works Buffer Area.
- c) watercraft approved by the Authority

The Marine Stadium Works Buffer Area is shown on map C4-150 attached to the Notice.

Reasons for the Notice

Consistent with the purposes of the *Gold Coast Waterways Authority Act 2012* and the functions of the Authority, I issue the Notice to allow for the Approved Work within the Works Buffer Area in a safe and orderly manner, unaffected by other watercraft for the duration of the work.

I make the requirements of the Notice for the following purposes:

- a) to maintain the effective and efficient management of certain waters of Marine Stadium
- b) to move and control the activities by watercraft in the Works Buffer Area
- c) to maintain fair and reasonable access to the Muriel Henschman Drive public boat ramp and pontoon.

I am satisfied the character and nature of the Approved Work requires movement and control of watercraft in the Works Buffer Area.

Contravention of the Notice

A person to whom the Notice applies must comply with each requirement of the Notice.

A contravention of a requirement of the Notice is an offence that carries a maximum penalty of \$13,785 for an individual, and up to five times that amount for a corporate entity.

A watercraft that is anchored, moored, or left in Gold Coast waters in contravention of a requirement of the Notice is ***contravening property***.

Recovery of expenses

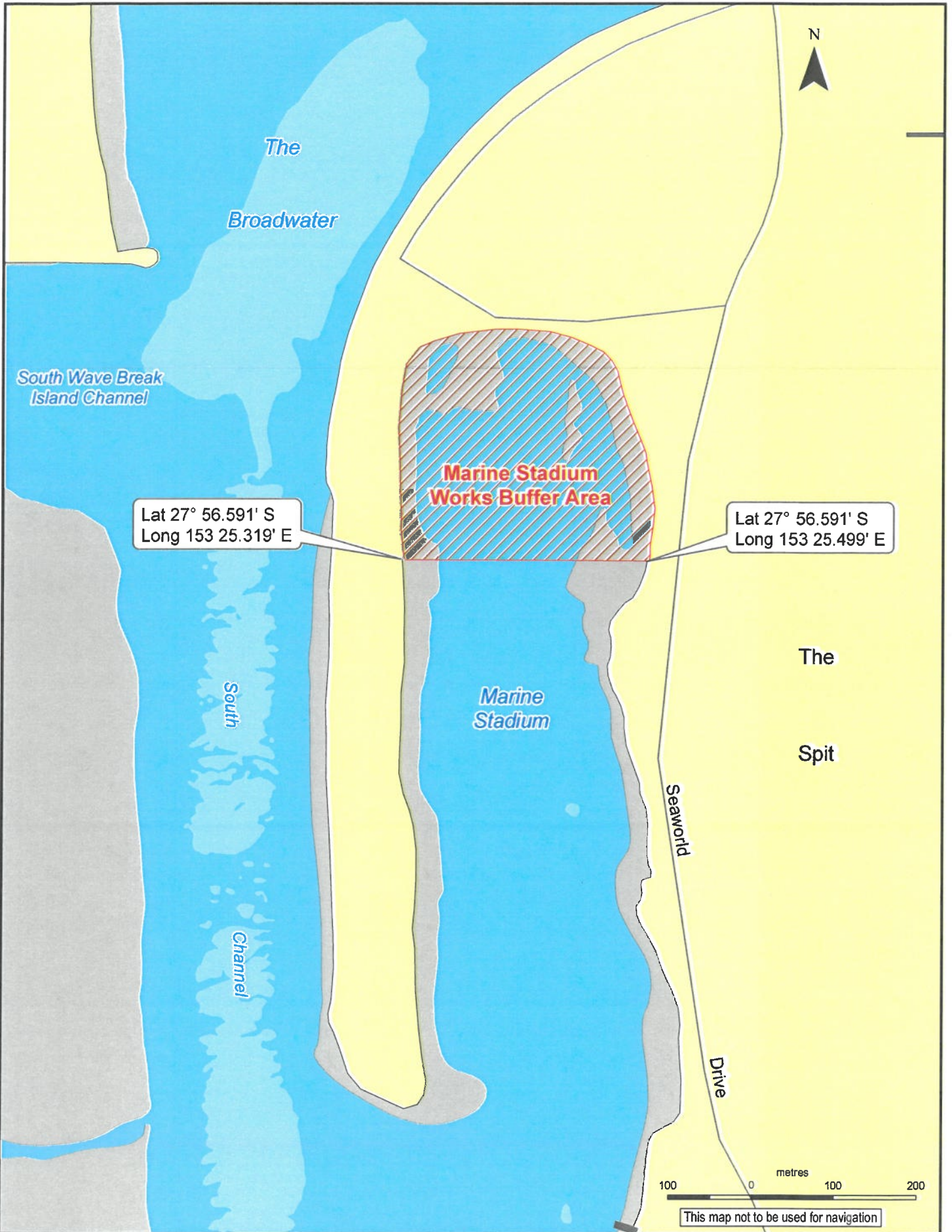
The Authority may take steps necessary and reasonable to move contravening property.

If the Authority incurs expenses in dealing with contravening property, the Authority may recover those expenses from the owner of the property as a debt payable to the State.
